The initiative identified a range of value creating opportunities that will move the business towards a world class manufacturing operation. Built and shared a roadmap highlighting the need for foundational investment followed by the introduction of value creating digital capabilities over 3-5 years The roadmap formed the basis of the annual and long-range business plans for the manufacturing function.
